# Upcoming Proposed Rule Making

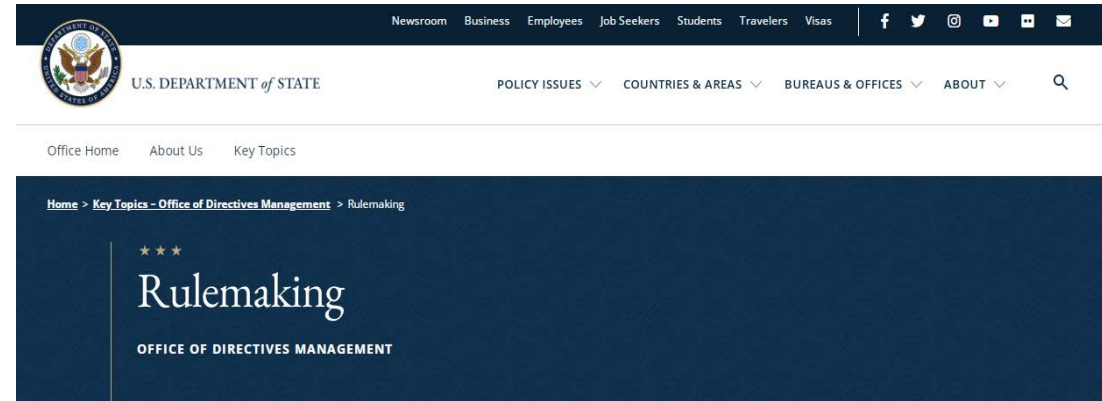
Ord No. 77-11 and 78-03 Updates coming to:

- 1) Airport Rules & Regulations
- 2) Minimum Standards

- Review process will exceed the national rulemaking process
- Each document is roughly 40-50 pages & will provide very clear guidance and reference for both the airport & tenants

Schedule: August 2020 through February 2023

- Sep 1<sup>st</sup> – Submit draft to the FAA for review
- Nov 1<sup>st</sup> – Tenant Public Meeting – Unveil draft
- Nov 1<sup>st</sup> – Dec 1<sup>st</sup> Public Review and Comment Period
- Dec 15<sup>th</sup> Tenant / Public Meeting – Final Review
- Jan 16<sup>th</sup> – BOCC Public Hearing Request
- Feb 6, 2023 – BOCC Public Hearing



# Updates & Review Process

- Received comments from the FAA
  - Legal counsel reviewed / addressed
- Clarification for Self-Service Labor Requirement
- Final Airport drafts complete
- Final drafts posted for public review Nov 1st
- Public Review Period = Nov 1<sup>st</sup> – Dec 1<sup>st</sup> 2022
- Comment Form – Format and Process
  - Submit all comments by December 1, 2022
