Need to Update Governing Documents

Current Documents Date from 1970s

- Do Not Reflect Current Levels and Kinds of Activity
- Lack of Defined Procedures for Compliance and Enforcement

Not Reflect Current Best Practices and Standards



Process

- Drafting began ~ Oct. 2021
 - Multiple Internal Drafts
- Review by County Attorney
- Input from Quadrex Aviation
- FAA Review by Orlando ADO Team
 - Minimal Comments

- County Draft: 43 Pages (including Appendices)
 - Boca Raton: 44 pages (with Exhibits)
 - Chicago Exec: 34 pages
 - Dallas Exec: 28 pages
 - Eagle: 32 pages
 - Martin Cnty: 60 pages (with Exhibits)
 - Napa: 47 pages
 - Mid-Carolina: 46 pages



Comparables – Minimum Standards

- County Draft: 48 pages (Including Appendices)
 - Braunfels: 59 pages (Including Appendices)
 - Eagle: 45 pages (Including Attachment)
 - Lantana: 41 pages (Including Attachment)
 - Martin: 43 pages (Including Attachments)
 - Napa: 39 pages (Including Attachment)
 - Truckee: 34 pages

Initial Review of Comments

- Very Pleased with Number and Detail of Comments
- Many Comments Make Useful Points and We Will Address
- Many Comments Assume the Worst
 - Clarification of Scope Can Address
- We will Respond to ALL Comments and Provide Opportunity for Further Comment



Initial Review of Comments

- Airports Director has Only Administrative Authority
 - "Deemed a Misdemeanor" Directly from Florida Statutes and County Code §3-93 – Still Requires Judicial Determination
 - Enforcement Authority tracks Code §3-85(a) and Industry
- BOCC Must Approve Amendments, Leases, Contracts, Operating Agreements, Etc.
- Administrative Penalty and Review Process is Common
